

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.ethosluxuryadvisors.com and Ethos Travel Planners LLC dba Ethos Luxury Travel and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Ethos Travel Planners LLC dba Ethos Luxury Travel include www.ethosluxuryadvisors.com, Ethos Luxury Travel, Green-Eyed Adventuress and www.greeneyedaadventuress.com. The Ethos Luxury Travel website is a ecommerce and blog site. By using the Ethos Luxury Travel website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Ethos Luxury Travel may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Ethos Luxury Travel's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Ethos Luxury Travel may also collect anonymous demographic information, which is not unique to you, such as your:
